- Izikhalazo ezingeenkonzo, ulawulo okanye iinkqubo zeSARS.
- Izikhalazo zifanele zihambisane nezicelo zemithetho-sihlomelo yerhafu.

IMIZEKELO YEZIKHALAZO ZE-OMBUD YERHAFU ENOKUZIQWALASELA

Iinkonzo - Ukungancedi, ukubetha ngooyaba okanye ubukrwada kwiiarhente zefowuni okanye abasebenzi bamasebe abasilelayo ukudlulisela inkcazelo xa icelwa.

Ulawulo - Ukukhupha isilumkiso sokuhlola esingenayo inkcazeo efana negama lomntu ohlolwayo okanye umhla wokuhlolwa.

Iinkqubo - Ukuhlola ngaphandle kwemvume evela kumhlawuli werhafu nesaziso sokukhutshwa "kokubuyela okwesithathu" (umyalelo ovela kwibhanki wokuhlawula iSARS ngeakhawunti yebhanki yakho) ngaphandle kokwazisa umhlawuli werhafu kwiintsuku ezilishumi ngaphambili.

NCEDA UPHAWULE ukuba izikhalazo eziqwalaselwa yi-OTO aziphelelenga kwezi zingasentla.

YINTONI ENGENAKWENZIWA YI-OMBUD YERHAFU?



I-Ombud yerhafu ayinakwenza ezi zinto zilandelayo:

- Ukuhlola imithetho-sihlomelo nemigaqo-nkqubo yerhafu.
- Imigaqo-nkqubo yakwaSARS okanye indlela eqhelekileyo yokwenza izinto, ngaphandle kokuba ihambisana neenkonzo, inkqubo okanye indlela yolawulo ngokwelungiselelo lesicelo soMthetho Werhafu wakwaSARS.
- Umbandela osalindiweyo kwisibheni esiphantsi koMthetho Werhafu, ngaphandle kombandela wolawulo kulowo uthunyelwe kwisibheni.
- Isigqibo ngenkqubo okanye umbandela ophambi kwenkundla yerhafu.

- Ngaphambi kwezo ziphumo, kufuneka ubonise ixesha lerhafu okhalazela ngalo, umze. 2016;
- Chaza umnqweno wakho ngesikhalazo. Xa ifunyenwe ifomu yesikhalazo,
- i-OTO iza kubhala isikhalazo sakho ikhuphe neleta yokuba isifumene; ize
- I-OTO iza kugqiba enoba iza kuwugwalasela umbandela okanye kuza kunconyelwa indlela onokuyilungisa ngayo ingxaki yakho.

NCEDA UPHAWULE: Ukuba akukho bugqina baneleyo, umbandela unokurhoxiswa, okanye isikhalazo sikhutshwe ngelinye ithuba ukuze kufunyanwe ubungqina obaneleyo.

INYATHELO 4: KWENZEKA NTONI EMVA KOKUFAKA ISIKHALAZO?

- I-OTO iza kuphanda umbandela ize iwumisele enoba isikhalazo sifika kwimiqathango ebekiweyo nokuba izikhalazo zihambe onke amanqanaba akwaSARS, nokuba umkhalazi unezibakala ezeyiselayo zokunenzi njalo okanye akazo. I-OTO iza kuphinda iqinisekisa enoba imiqathango iyasebenza nokuba esi sikhalazo esibambekayo.

- Ukuba izikhalazo zikwimigqaliselo ye-OTO, akukho zinkonzo, iinkqubo nolawulo alulandelwa kwicala likaSARS, i-ORO iza kuncomela indlela iSARS enokuyilungisa ngayo ingxaki. Ileta yolwamkelo iza kuthunyelwa kumkhalazi.

- Ukuba ityala liyakhatywa, ileta yeziphumo iza kuthunyelwa nesizathu sokuba isikhalazo sikhatywe.
