- Ihhovisi elingakhethi nelizimele elisungulwe ngo-Okthoba 2013;
- Lizinikele ekuxazululeni izikhalazo zabakhokhi bentela uma bamelene ne-SARS;
- Lizimisele ngokuqiniswa kokuthembeka nokuthembakala kwabakhokhi bentela ekuqondisweni kwentela.



IZIPHI IZINHLOBO ZEZIKHALAZO EZINGABHEKWA UMLAMULELI WENTELA?



- Izikhalazo kuphela ezifakwe zibhekiswe kwi-SARS; kanye
- Nezikhalazo ezihlobene nesevisi, ukuphatha noma inkinga yenqubo ye-SARS.
- Izikhalazo kumele zihlobane nokusetshenziswa komthetho wentela.

IZIBONELO ZEZIKHALAZO UMLAMULELI WENTELA ANGABHEKANA NAZO:

Isevisi – Abasebenzi abanganalo usizo, abanganabo ubungoti noma abaluhlaza besikhungo sokushaywa kocingo noma izisebenzi zegatsha ezihluleka ukunikeza ulwazi oluceliwe.

Ukuphathwa – Ukukhishwa kwesaziso sokuhlolwa esingenalo ulwazi oludingekayo olufana negama lomuntu ohlolwayo noma usuku lokuhlolwa.

Inqubo – Ukwenza ukuhlolwa ngaphandle kokunikeza umkhokhi wentela okhathazekile ngesaziso sokuhlolwa noma sokukhishwa “kwe-aphoyintimenti yenkampani yangaphandle” (ukuyalela ibhange lakho ukuthi likhokhele imali ku-SARS kusukela ku-akhawunti yakho yasebhange) ngaphandle kokunikeza abakhokhi bentela isaziso sezinsuku eziyishumi.

SICELA WAZI ukuthi izikhalazo i-OTO engabhekana nazo azikhawulelwe kulezo ezifakwe kuhlu ngaphezulu.

YINI UMLAMULI WENTELA ANGAKWAZI UKUYENZA?



Umlamuli wentela akumele abuyekeze:

- Umthetho noma inqubomgomo yentela.
- Inqubomgomo ye-SARS noma imvamise evamise ukuqhubeka, ngaphandle kwebanga lokuthi ihlobene nodaba lwesevisi noma udaba lwenqubo noma elokuphatha elivela kusukela ekusetshenzisweni kokunikezwa komthetho wentela we-SARS.
- Udaba olungaphansi kokuphikiswa kanye nesikhalazo ngaphansi komthetho wentela, ngaphandle kodaba lokuphatha oluhlobene nokuphikiswa okunjalo nesikhalazo
- Isinqumo sokuqhubeka kudaba enkantolo yentela noma ngaphambi kwayo.

KUMELE USIFAKE NINI ISIKHALAZO KUMLAMULI WENTELA?

Ngemuva kokuthi umkhokhi wentela enze zonke izindlela zezikhalazo ze-SARS, ngaphandle kokuthi kube khona izimo ezimphoqayo ukuthi angenzi njalo.

ISINYATHELO 2: QEDELA IFOMU NGOKUGCWELE.

- Bhala njengoba kunjalo isimo sesikhalazo sakho ngokulandelana kwezikhathi okufaka zonke izinombolo zecala ezihambelana nesikhalazo kusukela ku-SARS uphinde unamathisele onke amadokhumenti asekelayo;
- Yenza isiqinisekiso sokusebenzisa inombolo yenkomba yentela ehambisanayo;
- Ngaphambi komphumela ofiswayo, kumele udalule isikhathi sentela okhalaza ngayo isib. 2016;
- Isho ongathanda ukuthi kwenzekwe ngesikhalazo. Uma ifomu lesikhalazo selamukelwe,
- I-OTO izorekhoda isikhalazo iphinde ikhiphe incwadi yokwamukela; futhi
- I-OTO izonquma ukuthi izosiphatha kanjani noma ikuncomele ezinye izisombululo.



ISINYATHELO 3: SAYINA UPHINDE UFAKE USUKU KUWO ONKE AMAFOMU:

Uma usebenzisa oqokelwe ukukumela, okhalazayo kumele athumele; okufakazela amandla okumela, kuhambisana namakhophi ashaywe isitembu e-ID okhalazayo kanye noqokelwe ukuba ngummeli.

ISINYATHELO 4: KWENZAKALANI NGEMUVA KOKUTHI KUFAKWE ISIKHALAZO?

- I-OTO izophenya udaba futhi ithole uma ngabe okhalazayo ugena ngaphansi kwamandla ayo yini nokuthi ingabe wenze zonke izindlela zokukhalaza ze-SARS yini,
- I-OTO izophenya udaba futhi ithole uma ngabe okhalazayo ugena ngaphansi kwamandla ayo yini nokuthi ingabe wenze zonke izindlela zokukhalaza ze-SARS yini, uma kungenjalo, ithole uma ngabe okhalazayo unikezile yini ngezimo eziphoqa ukungenzi njalo. I-OTO izophinda iqinisekise uma ngabe kukhona imikhawulo esebenzayo iphinde ihlole uma ngabe isikhalazo silungile yini.
- Uma izikhalazo zitholakala zingaphakathi kwamandla e-OTO, okusho ukuthi kukhona ukuhluleka kwesevisi, kwenqubo noma okokuphatha kusukela kuhlangothi lwe-SARS, i-OTO izobese incama ku-SARS ukuthi ingalungisa kanjani isimo. Incwadi yokwamukela izothunyelwa kokhalazayo.
- Uma icala linqatshelwa, incwadi yomphumela izothunyelwa kokhalazayo ngezizathu zokunqatshelwa.



(NB: Ibhovisi Lomlamuli wentela lizokwenza uphenyo oluzimele, olungachemile nolungakhethi ukuze kuqinisekise ukuthi isikhalazo somkhokhi wentela esibhekiswe ku-SARS sixazululwa ngokushesha, kanye/ noma ulwazi nokuxhumana kuthathwa njengokuyimfihlo kakhulu).

UKUZIKHIPHA ECALENI

Ulwazi olunikezwe kule dokhumenti luvikelwe imithetho esebenzayo yemicabango yabantu futhi akumele lukopishwe, lusatshalaliswe noma lushintshelwe noma iziphi izinjongo zokuhweba. Ulwazi oluqukethwe kuleli bhukwana belikade lilungile ngesikhathi sokushicilelwa kodwa kungenzeka ukuthi lubuye lashintshwa. Uma kungaba khona ukungabaza mayelana nokulunga noma uma unganayo inguqulo yakamuva yaleli bhukwana sicela ushayele isikhungo sokuxhumana ku-0800 662 837 ukuze uqinisekise. Leli bhukwana elezinjongo zolwazi kuphela futhi aluthathwa njengenkombha yezomthetho. Ukusetshenziswa kwalolu lwazi inoma imuphi umuntu kuzoba ngokwazi kwaloyo muntu kuphela. Ihhovisi lomlamuli wentela aliqokelwe ukumela ngokuboniswa noma ngokuhlongozwa, alincomi noma aliphakamisi ukuthi imikhiqizo noma amasevisi ashiwo kuleli dokhumenti alungele izidingo zomuntu othile. Umlamuli wentela akamukeli noma ikuphi ukuba secaleni ngenxa yokulahlekelwa, ukonakalelwa, izindleko nezincithakalo ezingatholwa noma zibe khona ngokuqondile noma ngokungaqondile njengomphumela wanoma iliphi iphutha noma okukhishiwe okuqukethwe kuleli dokhumenti.
