Sikhuthaza ubumfihlo bomkhokhintela

I-OTO yasungulwa kuMfumfu kowezi-2013 ngenhloso yokuthuthukisa uhlelo lokuphathwakwentedela eNingizimu Afrika. Kuze kube ingaleso sikhathi, yayingekho indlela ezimele yokubhekana nezikhalazo zabakhokhintela okutholakala ukuthi sebezisebenzise zonke izindlela ezikhona ezivamile zokukhalaza kwasARS kube ukuthi abasizakali. Njengomgudu wokulungisa wabakhokhintela, siphokophele ukuqinisekisa ukuthi abakhokhintela bathola usizo kongoti futhi baphathwa ngendlela enobulungiswa okuyizinto ezipemalungelweni abo kwaSARS kanu-OTO.

YILUPHI USIZO ESILUHLINZEKAYO?

Umyalelo Womlamuleli Wezentela ukubukeza nokulungisa nasiphi isikhala zo esenziwe umkhokhintela mayelana nodaba losizo, Iwenqubo noma lokuphathwa kodaba oluvela kusicelo sokuhlinzekelwa uMthetho weNtela wakwaSARS. Phezu kwalokho, lapho uNgqongqoshe noma lapho Umlamuleli Wezentela yenzo ngokugunyazwa uNgqongqoshe, ibuyekeza izindaba ezithinta uhlelo nezindaba ezivelayo ezimayelana nodaba oluthinta usizo noma ukusetshenziswa kokuhlinzekelwa uMthetho Wokuphathwa Kwentela noma okuhlinzekelwa inqubo noma ukuphatha ngokoMthetho wentela.

IZINKINGA ZOHLELO LOKUSEBENZA: ODINGA UKUKWAZI

Inkinga yohlelo lokusebenza odabeni oluthile lungathathwa njengembangela yesikhala zo esithinta noma esingathinta abakhokhintela abanangi ohlelwani lwentela. Izinkinga zohlelo lokusebenza zingabangelwa indlela izinhlelo ezithile zakwaSARS ezisebenza ngazo, indlela uSARS obhala ngazo nosebenzisa ngazo izinqubomgom, izindlela zokwenza noma izinqubo, noma indlela uSARS osebenzisa ngayo noma ongasebenzisi ngayo okuhlinzekelwa umthethonqubo.

SIZHLONZA KANJANI IZINKINGA ZOHLELO LOKUSEBENZA NEZIVELAYO?

Lapho sihlonda futhi sihlola izinkinga abakhokhintela abahlangabezana nazo, i-OTO ibheka izinto ezifana nalezi:

- Umthelela walolu daba emalungelweni omkhokhintela;
- Umthelela omubi walolu daba kuSARS;
- Ubucayi bodaba; kanye
- Nesibalo sabakhokhintela abathintekayo.

Sibe sesikhipha isincomo esisemthethweni esibeka izinto eziholele esinqumweni sethu sokuhlonza inkinga njengenkinga yohlelo kusebenza noma udaba oluvelayo.



KUNINI LA UFAKA KHONA ISIKHALAZO?

Ngaphambi kokuya kuMlamuleli Wezentela, abakhokhintela kumele baqinisekise ukuthi sebezisebenzise zonke izindlela zokusombulula isikhalaZo ngaphakathi kwaSARS ngaphandle uma kunezimo eziphoqayo zokuthi kungenziwa kanjalo.

Ukuze ayise isikhalaZo sakhe kwaSARS, umkhokhintela kudingeka ashayele eHhovisi Lokuphathwa Kwezikhalazo kwaSARS (i-CMO) kule nombolo 0860 121 216 noma aye ku-eFiling. Uma kungukuthi nalapho akanelisekile ngendlela uSARS asiphathe ngayo isikhalaZo sakhe, noma uma i-SARS CMO ingakasiphothuli isikhalaZo sakhe emva kwezinsuku zokusebenza ezingama-21 kusukela ngosuku owasifaka ngalo, engaya eHhovisi Lomlamuleli Wezentela.

Uma isikhalaZo sakho singena ngaphansi komyalelo wethu, sizosemukela, siphene ngaso bese sinika izincomo zethu kwaSARS ukuthi bangasisombulula kanjani lesi sikhalaZo.

YIZIPHI IZIMO EZIPHOQAYO?

UMthetho Wokuphathwa Kwentela ubeka lezi zinto ezilandelayo okumele uMlamuleli Wezentela izikubheke lapho izama ukuthola ukuthi ngabe izimo "ziyaphoqa" na:

- isicelo sikhuluma ngezinkinga zohlelo lokusebenza;
- ukulandela uqede zonke izindlela zokusombulula izikhalaZo kuzokwenza kube nzima kulowo ofaka isikhalaZo; noma
- ukulandela uqede zonke izindlela zokusombulula isikhalaZo akubonakali ukuthi kungaba nomphumela esikhathini i-Tax Ombud esibona njengesifanele.

Umlamuleli Wezentela kumele lazise umfakisikhalaZo ngokuthi yisiphi isinyathelo esizothathwa, uma sikhona.

OKUNGEKE KWENZIWE NGUMLAMULELI WEZENTELA

Umlamuleli Wezentela angeke akubukeze lokhu:

- Umthethonqubo noma inqubomgomo yentela;
- Inqubomgomo kaSARS noma into okuyinto eyenziwayo;
- Udaba oluphikiswayo noludluliswayo ngaphansi koMthetho wentela, ngaphandle kodaba lokuphatha olumayelana nokuphikiswa nokudluliswa; kanye
- Nodaba oluphambi kwenkantolo yentela noma isinqumo esenziwe enkantolo.

SISEBENZA KANJANI?

Sizimisele ngokusombulula izikhala zo zakho ngokushesha

Imizamo yethu yokusombulula izikhala zo ibandakanya lokhu okulandelayo:

- Ukuhlola nokubukeza isikhala zo sakho ukuthola ukuthi ngabe singena ngaphansi komyalelo wethu bese silungisa ukuhlola kwesikhashana kwesikhala zo sakho.
- Uma kungukuthi asingeni ngaphansi komyalelo wethu noma sifakte kungakafaneli, incwadi yomphumela wokuhlola izothunyelela kumkhokhintela.
- Uma singena ngaphansi komyalelo wethu futhi nomlamuleli Wezentela iqinisekile ukuthi uSARS uhlulekile ukulandela inqubo efanele kumkhokhintela, ukuphatha ngendlela noma awuzange uhlangabezane nezithembiso zavo zosizo oluhlinzekayo, izincomo zokuthi singasonjululwa kanjani zizothunyelwa kwaSARS.
- USARS uzobe usuphendula ngombiko ochaza ngokuthi basisombulule kanjani isikhala zo, esizobe sesihlolwa yUmlamuleli Wezentela bese ithumela incwadi yokuphothulwa kodaba kumkhokhintela eveza ukuthi isikhala zo sisonjululwe kanjani.

Umlamuleli Wezentela angase asho ukuthi kumele ukubukeza kwenziwe kanjani. Lokhu kungase kubandakanye ukwenza izincomo zokuthi isikhala zo sisonjululwe ngokungenelela noma ukuxolela uma kunesidingo.

IZINCOMO ZOMLAMULELI WEZENTELA KWASARS

Izincomo zethu azimbopheleli uSARS noma umkhokhintela. Noma kunjalo, uma ungazemukeli izincomo zethu, ukhululekile ukuthumela izizathu zakho zaloku kuMlamuleli Wezentela ezinsukwini ezingama-30 emva kokuthola izincomo zethu. Umlamuleli Wezentela ingazifaka izizathu ezinkwe embikweni oya kuNgqongqoshe noma kuKhomishana ngaphansi kwesigaba 19 soMthetho Wokuphathwa Kwentela.

SIZINIKELA KANJANI EKUGCINENI UBUMFIHLO?

IHHovisi Lomlamuleli Wezentela linomthwalo ngokomthetho wokuvikela ubumfihlo bolwazi lomkhokhintela, kanti zonke izisebenzi zethu zisayinda Isifungo Sobumfihlo.

Lezi zidingo zobumfihlo zibekwe kusigaba 21(2) zoMthetho Wokuphathwa Kwentela. Umlamuleli Wezentela namuphi omunye umuntu osebenza egameni le-Ombud akakwazi ukudalula naluphi ulwazi kwasARS uma kungukuthi lutholwe noma egameni Lomlamuleli Wezentela, noma lulungiswe ngolwazi olutholakale noma egameni Lomlamuleli Wezentela, ngaphandle kokuba kuze kube yisidingo sokwenza imisebenzi yaso ngaphansi koMthetho.

UMthetho uthi uSARS kumele uvumele Umlamuleli Wezentela ithole ulwazi olumayelana namandla nemisebenzi yoMlamuleli Wezentela.

Uma unomuntu okumelele, kumele uthumele incwadi enika igunya kanye namakhophi agxiviziwe kamazisi wakho neyommeleli wakho.

Ungalidawuniloda lapha ifomu lokunika igunya **Ifomu Lencwadi Enika Igunya** kusizindalwazi se-OTO ngaphansi kwe**Zikhala**zo.

Khumbula ukuthi bobabili umfakisikhala zo nommeleli wokhokhintela kumele bawasayinde amafomu.

SICELA UQAPHELE: Uma uhlinzeka ngobufakazi obunganele bokufakazel a isikhala zo sakho, i-OTO ingase iphoqeleke ukuba ilumise udaba lwakho. Kungenjalo, ungase unikwe elinye ithuba lokuhlinzeka ngobufakazi obudingekayo.

KWENZAKALANI EMVA KOKUFAKWA KWESIKHALAZO?

- I-OTO izohlola daba bese ithola ukuthi ngabe isikhala zo singena ngaphansi komylelo wethu na nokuthi umfakisikhala zo usezilandele zonke na izindlela zokusombulula isikhala zo kwaSARS. Uma kungukuthi izindlela zakwaSARS zokusombulula azilandelwanga kuqala, sizobheka ukuthi ngabe wena njengomfakisikhala zo usihlinzekile na ngezimo eziphooqayo zokungakwenzi lokho, noma uma i-OTO ingakuhlonzela izimo eziphooqayo ezenza ukuthi ungaqali ngokulandela izindlela zakwaSARS zokufaka isikhala zo. I-OTO izophinde iqinisekise ukuthi ngabe kukhona yini okuyizithibelo ezisebenzayo iphindie ibheke nokuthi isikhala zo sisemthethweni.
- Ukuthi ngabe izikhala zo zingaphansi komylelo we-OTO (okusho ukuthi kukhona okungahambanga ngendlela ekuhlinzekweni kosizo, enqubweni elandeliwe noma ekuphathweni okwenzeke kwaSARS), i-OTO izobe isiyenza izincomo ziye kwaSARS ngokuthi singalungiswa kanjani isimo.
- Sizophinde sithumeleinwadi yokwamukela kuwe, wena mkhokhintela.

Uma udaba luchithiwe, incwadi enomphumela izothunyelwa kuwe inezizathu zokuthi kungani luchithiwe.


YAZI AMALUNGELO AKHO

I-OTO iyaqhube kaSARS kanye nezibophezelo zomkhokhintela, izindlela zokulungisa kanye namalungelo. Sikhiqize isiqondiso **Incwajana Yamalugelo, Okusemalungelweni kanye neziBophezelo ZOmkhokhintela** enolwazi mayelana namalungelo, okusemalungelweni kanye nezibophezelo zabakhokhintela mayelana nezindaba zabo zentela nokuxhumana kwabo noSARS ne-OTO.

Lolu shicilelo oluhlanganisiwe aluphoqeleti "Umqulu Wamalungelo Abantu" kodwa luwushicilelo oluhlanganisiwe lwemigomo equkethwe kumadokhumenti ahlukahlukene, kubandakanya uMthethosisekelo, umthetho-nqubo wentela kanye namanye amadokhumenti kahulumeni.

Noma imaphi amalungelo kanye nokusemalungelweni okukhulunye ngakho kulolu shicilelo oluhlanganisiwe kungase kube nalapho kungasebenzi khona futhi kunqindwe ngokuvunyelwe umthetho. Ushicilelo oluhlanganisiwe alungeni endaweni, alukho ngaphezulu noma alukho ngaphezulu ngomthetho kunoma imuphi umthetho-nqubo, imigomo yemithetho noma izinqubo ezihambisana nokuphathwa kwentela.

Abakhokhintela bayelulekwa ukuba bafune usizo kubantu abanesipiliyonu uma befuna ukusebenzisa amalungelo abo. Kuyaziwa ukuthi ukusebenzisa amalungelo omuntu kuvame ukuba kudinge ukuthi izinto ezibizayo enkantolo.
