Sivuselela ukuthemba koMhlawuli weRhafu

I-OTO yasekwa ngo-Oktobha 2013 ukunyusa inkqubo yolawulo lwerhafu eMzantsi Afrika. De kube ngoko, kwakungekho jelo lizimeleyo lokulungisa kubahlawuli berhafu abagqibe zonke iindlela zezikhalazo ze-SARS eziqhelekileyo kwaye babe bengekancedwa. Njengejelo lokulungisa kubahlawuli berhafu, sizamela ukuqinisekisa ukuba abahlawuli berhafu bafumana inkonzo enobugcisa kunye nokuphathwa ngokufanelekileyo abanelungelo lakho ngu-SAR ne-OTO.

ZIYINTONI IINKONZO ZETHU?

Igunya loMsombululi weziKhalazo zeRhafu kukuqwalasela kwakhona nokuthathela ingqalelo nasiphi na isikhalazo somhlawuli werhafu malunga nenkonzo, umcimbi wenkqubo okanye wolawulo ovela ekusetyenzisweni kwamagatya omThetho ngu-SARS. Ukongeza, ngesicelo soMphathiswa okanye ngephulo loMsombululi weziKhalazo zeRhafu ngemvume yoMphathiswa, siqwalasela kwakhona naziphi na iingxaki ezikwinkqubo iphelele kunye nemiba evelayo enxulumene nomcimbi weenkonzo okanye ukusetyenziswa kwamagatya omThetho woLawulo lweRhafu okanye amagatya enkqubo okanye olawulo omThetho werhafu.

IINGXAKI ZICHAPHAZELA INKQUBO YONKE: INTO EKUFUNEKA UYAZI

Ingxaki echaphazela inkqubo yonke ngumcimbi othile ongathathwa ngunobangela obukhona wesikhalazo ochaphazela okanye oza kuchaphazela abahlawuli berhafu abaninzi kwinkqubo yerhafu. Iingxaki ezichaphazela inkqubo yonke zinokuvela ngenxa yendlela ezisebenza ngayo iinkqubo ezithile ze-SARS, indlela equlunqa kwaye iphumeze ngayo imigaqonkqubo, imisebenzi okanye iinkqubo i-SARS, okanye indlela esbenzisa okanye ede ingahoyi ngayo amagatya.

SIZICHONGA NJANI IINGXAKI EZINGAMANDLA KWINKQUBO KUNYE NEMIBA EVELAYO?

Xa ichonga kwaye ihlola imiba eyahlukeneyo abahlangabezana nayo abahlawuli berhafu, i-OTO ithathela ingqalelo imiba emininzi efana:

- neempembelelo zomba kumalungelo omhlawuli werhafu;
- iimpembelelo ezimbi zomba ku-SARS;
- ubunzulu bomba; kunye
- nenani labahlawuli berhafu abachaphazelekayo.

Siye ke sikhuphe isiphakamiso esimisela imiba ekhokelela kwisigqibo sethu sokuchonga umba njengoyingxaki kwinkqubo xa iyonke okanye umba ovelayo.

USIFAKA NINI ISIKHALAZO?

Phambi kokuya kuMsombululi weziKhalazo zeRhafu, abahlawuli berhafu kufuneka baqinisekise ukuba basebenzise zonke iindlela zokusonjululwa kwezikhalazo zangaphakathi ze-SARS ngaphandle kokuba iimeko ziyanyanzelisa zokuba kungenziwa oko.

Ukusa isikhalazo ku-SARS, umhlawuli werhafu kufuneka aye kwiOfisi eLawula iziKhalazo (Complaints Management Office) (CMO) ye-SARS ku- **0860 121 216** okanye kwi-eFiling. Ukuba ngaba awukoneliseki ngendlela asiphethe ngayo isikhalazo sakho u-SARS, okanye ukuba i-SARS CMO ayisigqibi isikhalazo sakho kwiintsuku ezisemva kwezingama-21 zokusebenza ukusukela kumhla osifake ngawo, ungaya kwiOfisi yoMsombululi weziKhalazo zeRhafu.

Ukuba isikhalazo siwela kwigunya lethu, siza kusamkela kwaye sisiphande size sinike u-SARS iziphakamiso zethu ekubeni usisombulula njani isikhalazo.

ZEZIPHI IIMEKO EZINYANZELAYO?

UmThetho woLawulo lweRhafu umisela imiba elandelayo leyo uMsombululi weziKhalazo zeRhafu aya kuyithathela ingqalelo xa emisela ukuba imeko iimeko inokuba “iyanyanzela” na:

- isicelo siphakamisa iingxaki kwinkqubo xa iyonke;
- ukusebenzisa zonke iindlela zokusonjululwa kwesikhalazo kuza kubanga ubunzima obungafanelekanga kumceli; okanye
- ukusebenzisa zonke iindlela zokusonjululwa kwesikhalazo akubonakali kunokwenzeka ukuba kuveze isiphumo kwithiuba elo uMsombululi weziKhalazo zeRhafu alibona njengokuba lifanelekile.

UMsombululi weziKhalazo zeRhafu kufuneka azise umfaki sikhalazo ngokuba leliphi inyathelo eliza kuthathwa, ukuba kukho naliphi.

INTO ANGEKE AYENZE UMSOMBULULI WEZIKHALAZO ZERHAFU

UMsombululi weziKhalazo zeRhafu ngeke aqwalasele kwakhona:

- umthetho okanye umgaqonkqubo werhafu;
- Umgaqonkqubo we-SARS okanye imisebenzi ekhoyo jikelele;
- umcumbi oxhomekeke kwinkcaso kunye nesibheni phantsi komThetho werhafu, ngaphandle komcumbi wolawulo onxulumene nenkcaso nesibheni; kunye
- nomcumbi werhafu ophambi kwenkundla yerhafu okanye isigqibo esenziwe enkundleni.

SISEBENZA KANJANI?



Sizamela ukusombulula izikhalazo zakho ngokukhawuleza.

Iinzame zethu zokusombulula izikhalazo ziphathelele nokulandelayo:

- Ukuhlola nokuqwalasela kwakhona isikhalazo sakho ukumisela ukuba siwelakwigunya lethu na kunye nokulungisa uhlolo lokuqala lwesikhalazo sakho.
- Ukuba asiweli phantsi kwegunya lethu okanye sifakwe ngaphambi kwexesha isiphumo seleta yohlolo siza kuthunyelwa kumhlawuli werhafu.
- Ukuba siwela kwigunya lethu kwaye uMsombululi weziKhalazo zeRhafu uqinisekile ukuba u-SARS akamncedanga umhlawuli werhafu ngokwenkqubo, ulawulo okanye khangela ahlangebezane nezithembiso, iziphakamiso zakhe zenkonzo ekubeni usisombulula kanjani siza kuthunyelwa ku-SARS.
- U-SARS uza kuphendula ngengxelo eshwankathelayo ekubeni basisombulule kanjani isikhalazo, eso uMsombululi weziKhalazo zeRhafu aza kusihlola aze athumele ileta yokusigqibezela kumhlawuli werhafu ekhombisa esisonjuluwe ngayo isikhalazo.

UMsombululi weziKhalazo zeRhafu uza kumisela ukuba kufuneka luqhutywe kanjani uqwalaselo kwakhona. Oku kunokuquka ukuphakamisa ukuba isikhalazo sisonjululwe ngolamlo okanye uxolelaniso ukuba kuyimfuneko.

IZIPHAKAMISO ZOMBULULI WEZIKHALAZO ZERHAFU KU-SARS

Iziphakamiso zethu azibopheleli ku-SARS okanye kumhlawuli werhafu. Nokuba kunjalo, Ukuba ngaba awuzamkeli iziphakamiso zethu, ukhululekile ukuba uthumele izizathu zakho koku kuMsombululi weziKhalazo zeRhafu kwiintsuku ezingama-30 zokufumana iziphakamiso zethu. UMsombululi weziKhalazo zeRhafu unokuquka izizathu ezinikiweyo kwingxelo eya kuMphathiswa okanye uMkomishinala phantsi kwecandelo 19 lomThetho woLawulo lweRhafu.

SIZIBOPHELELA KANJANI KUBUMFIHLO?

IOfisi yoMsombululi weziKhalazo zeRhafu inyanzelekile ngokomthetho ukuba ikhusele ulwazi oluyimfihlo lomhlawuli werhafu, kwaye bonke abasebenzi bethu basayina isiFungo sobuMfihlo.

Ezi mfuneko zobumfihlo zimiselwe kwiCandelo 21(2) lomThetho woLawulo lweRhafu. UMsombululi weziKhalazo zeRhafu kunye naye nawuphi na umntu osebenza egameni loMsombululi weziKhalazo zeRhafu akanako ukuxela naluphi na ulwazi ku-SARS ukuba lufunyenwe nguye okanye egameni lakhe uMsombululi weziKhalazo zeRhafu, okanye olulungiswe kulo naluphi ulwazi olufunyenwe nguye okanye egameni lakhe uMsombululi weziKhalazo zeRhafu, ngaphandle kwaxa efuna ukwenza imisebenzi yakhe phantsi komThetho.

UmThetho uyaxela ukuba i-SARS kufuneka yenze uMsombululi weziKhalazo zeRhafu afikelele kulwazi olunxulumene namagunya nemisebenzi yoMsombululi weziKhalazo zeRhafu.

INYATHELO 3: SAYINA KWAYE UFAKE IMIHLA KUZO ZONKE IIFOMU

Ukuba usebenzisa ummeli, kufuneka ungenise uxwebhu olunikezela ngamagunya kunye neekopi eziqinisekisiweyo zee-ID eyakho neyommeli wakho.

Unokudawunlowuda iFomu **yokuNikezela ngamaGunya** kwiwebhusayithi ye-OTO phantsi **kweZikhalazo**.

Khumbula ukuba bobabini umfaki sikhalazo serhafu kunye nommeli womhlawuli werhafu kufuneka basayine iifomu.

NCEDA UQAPHELE: Ukuba unika ubungqina obungonelanga bokuxhasa isikhalazo sakho, inokunyanzeleka ukuba iwurhoxise umcimbi i-OTO. Ngenye indlela, unokunikwa elinye ithuba lokunika ubungqina obuyimfuneko.

KWENZEKA NTONI EMVA KOKUBA SIFAKIWE ISIKHALAZO?

- I-OTO iza kuwuhlola umcimbi kwaye imisele ukuba ingaba isikhalazo siwela kwgunya layo na kunye nokuba umfaki sicelo uzigqibe zonke iindlela zezikhalazo ze-SARS. Ukuba iindlela ze-SARS azilandelwanga kuqala, siza kujonga ukuba ingaba wena njengomfaki sikhalazo unike iimeko ezinyanzelisayo zokungakwenzi oko, okanye ukuba uMsombululi ziKhalazo zeRhafu unokuzichonga iimeko ezinyanzelisayo kuwe ukuba ungasebenzisi ugqibe kuqala indlela yezikhalazo ne-SARS. I-OTO iza kuqinisekisa kananjalo ukuba ingabanayiphi na imida iyasebenza na kwaye ikhangele ukuba sinyanisekile na isikhalazo.
- Ukuba ingaba izikhalazo zikwigunya le-OTO (okuthetha ukubakukho intsilelo yenkonzo, yenqubo okanye yolawulo na ku-SARS), i-OTO iya kuthi ke icebise u-SARS ekubeni uyilungisa kanjani na imeko. Siza kuthumela kananjalo ileta yokwamkela kuwe, njengomhlawuli werhafu.
- Ukuba imeko iyakhatywa, ileta yesiphumo iza kuthunyelwa kuwe kunye nezizathu zokukhatywa.



Qiniseka ukuba ugcwalisa iindawo ezifanelekileyo kwaye uhlomele namaxwebhu axhasayo.

WAZI AMALUNGelo AKHO

I-OTO ifunangokuqhubeka ukukhuthaza ungqinelwano olufanelekileyo phakathi kwamagunya nemisebenzi ka-SARS kunye nezibophelelo, amancedo kunye namalungelo. **Sivelise uQulunqo lwamaLungelo oMhlawuli weRhafu, Okufanelekileyo neziBophelelo** ngolwazi malunga namalungelo, iimfanelo nezibophelelo eziphathelele nemicimbi yabo yerhafu kunye nokubandakanyeka kwabo ne-SARS ne-OTO.

Olu Qulunqo ayiinguwo “uMqulu wamaLungelo” onyanzelwayo kodwa luqulunqo nje lwemithethosiseko equlunqwe kumaxwebhu awohlukeneyo, kuquka uMgaqo-siseko, umthetho werhafu kunye namanye amaxwebhu karhulumente.

Nawaphi na amalungelo neemfanelo ekubhekiselwe kuQulunqo zinokuxhomekeka kokungaqukwayo kwaye zinokumiselwa umda ukuya kuma apho kuvunyelwe khona ngumthetho. Uqulunqo alungeni, longamele, okanye lususe nawuphi na umthetho, imithetho siseko yomthetho ongabhalwanga okanye iinkqubo ezinxulumene nolawulo lwerhafu.

Ulwazi oluqulethwe kule ncwadana beluchanekile ngexesha lopapasho kodwa kunokwenzeka ukuba luye lwatshintsha emva koko. Ukuba ngaba kukho nawuphi amathandabuzo malunga nokuchaneka, okanye ukuba awunayo inguqulelo yamva yale ncwadana, nceda utsalele umnxeba iZiko loQhagamshelwano le-OTO ku 0800 662 837 ngoqinisekiso.

Le ncwadana yeyeenjongo zolwazi kuphela kwaye ayinakuthathwa njengongqinisiso olusemthethweni. Nakuphi ukusetyenziswa kolu lwazi kuza kuba ngokwengqiqo epheleleyo yomfundi walo. IOfisi yoMsombululi weziKhalazo zeRhafu ayimelanga ngokucacileyo okanye ngokucetyiswayo, icebise okanye iphakamise ukuba iinkonzo ekubhekiselwe kuzo kolu xwebhu zifanelekile kwiimfuno zakhe nawuphi na umntu othile. UMsombululi weziKhalazo zeRhafu akathathi naluphi na uxanduva ngenxa yayo nayiphi ilahleko, umonakalo, iindleko neentlawulo, ezinokuba zifunyenwe okanye zenziwe ngokungqalileyo okanye ngokungangqalanga ngenxa yempazamo okanye okushiyeiweyo okuqulethwe kolu xwebhu.
